Solar Company Stion to Relocate to South San Jose's Industrial Park

Stion will add jobs and new technology to emerging solar cluster

SAN JOSE, CALIF. – Following actions taken today by the San Jose City Council, acting as the Redevelopment Agency Board, San Jose will soon be welcoming Stion Corporation, its third solar manufacturer in the Edenvale industrial area of South San Jose.

“The City Council and I want San Jose to be the world center for clean tech innovation, and bringing quality companies like Stion to San Jose is part of our strategy for reaching this goal,” said Mayor Chuck Reed. “We’ve set a goal of creating 25,000 jobs in emerging clean and green industries and are looking to the emerging solar industry to help create those jobs.”

The action today is one step in the implementation of San Jose’s Green Vision, an ambitious and comprehensive 15-year plan to solve environmental problems and grow the local economy. Focused around three elements – Clean Tech Innovation, Sustainability, and Green Mobility – San Jose’s Green Vision is a roadmap for the City to become the world’s center of Clean Tech Innovation.

As part of the Agreement, the San Jose Redevelopment Agency will provide \$700,000 to Stion for the purchase of manufacturing equipment. Also, the City of San Jose’s Office of Economic Development and Work2future, which provides

comprehensive resources to job seekers and employers in San Jose and Santa Clara County, is working with Stion to secure State Employment Training Panel Funds to help support Stion's workforce training needs.

Founded in June 2006, Stion is developing higher efficiency thin-film modules using proprietary materials. Its goal is to minimize the total installed cost of solar electricity by reducing panel costs and other related system costs, both of which are area-dependent and decrease as the product becomes more efficient. The company currently has 35 employees and raised a \$15 million Series B financing in June 2007 to accelerate its product development.

Stion has entered a lease agreement with Mission West Properties to occupy a facility at 6321 San Ignacio Avenue which was formerly owned and occupied by IBM. The facility will house both Stion's corporate headquarters as well as its initial production capabilities. Cornish and Carey real estate brokers, Jay Phillips and Sherry Gubera, represented Stion in this transaction.

"We are excited to join the growing number of cleantech firms that have settled in San Jose," said Stion's President and CEO, Chet Farris. "The Redevelopment Agency's work was instrumental in our decision to move to Edenvale, and our new facility provides us an ideal location to grow our company and launch our product."

Attracting emerging technology companies to the Edenvale Redevelopment Project Area is a key goal of the Redevelopment Agency's Edenvale Emerging Technologies Fund program. Since the inception of the Fund in 2006, Stion is the third solar technology company to move to Edenvale, following similar agreements with Nanosolar and SoloPower. Other companies located in the Edenvale Technology Park include GE, Hitachi and Northrop Grumman.

"Stion's decision to relocate to Edenvale serves to exemplify the future of our City and Silicon Valley," said Councilmember Forrest Williams. "Innovations such as the ones being developed by Stion, will serve to shape the future of our city and the world. As the epicenter of technological growth and development, our city and region will continue work towards solutions to address the problems of today and tomorrow through technology. I am proud to have Stion in Edenvale and welcome them to District 2."
